

At this time her name is given as Helen E Shafner, she is living at 6 Allen St., with her parents and her brother Raymond Kelland Shafner and next door to her grandparents George and Mary Ann Kelland and her Aunt Hattie B (Harriet) Kelland. She is 13 years old and is still attending school.

She next appears in the Lynn Directories for 1907 to 1912. She is now named Estella S Shafner and she is shown as a Stenographer working at 35 Central Square and living at 6 Spencer St., Lynn. As can be seen by the Census record below, this is also her parents address.

The 1910 Census for Allen St., Lynn, MA.

This is the Census taken 10 years later. The family are now living at 6 Spencer St., Lynn but now she is named as Sadie E. Her grandparents and aunt are still living next door to them, but Sadie is now 23 years old and is working as a Stenographer for an Insurance Company.

The reason she no longer appears in the Lynn Directory is that she gets married somewhere around 1913. I have a copy of a letter written by George H. Kelland (her uncle) which says "They spoke to me about Rob being a flower girl for Stella and I said she would". The letter was dated August 14th 1913. It was kindly sent to me by Ann Garland.

Another piece of information that Ann Garland kindly sent me can be seen below. Just what it all means I am not sure, did she inherit some money from her grandfather George Kelland Jr. who died in 1906? Not knowing exactly what it all means I just wonder, with the last entry being in 1919, is this about the time that she and her husband leave Lynn, MA, and move to New Haven Connecticut, where I found them on the 1920 Census?

He has an older sister Louise and both of them are still at school. Both of his parents were born in New York State as were his father's parents. Burton R is shown as being born in January 1887.

By 1910 Burton R Reynolds, now aged 23 years, has left New York State and is lodging at 368 Summer St., Lynn, MA. He is working as a machinist at an Electrical works! Just when he came to Lynn I do not know, but it is here that he met Estella/Sadie Shafner and they subsequently married in 1913, I believe.

Burton R Reynolds and his wife Sadie (Shafner) Reynolds are now renting 115 Bassett St., New Haven, CT, she is not working and he is working as a toolmaker in a gun factory.

This is the 1930 Census for Bassett St., New Haven, CT.

10 years later, Burton and Sadie are still living at 115 Bassett St., for which they pay a monthly rent of \$35. This Census even records if a family own a radio, which they do! Burton R is still working as a tool maker in a gun factory and Sadie E is still not working. It is interesting that the E has been included in Sadie's name on this Census. Also it states that her father (John Lithgow Shafner) was born in Nova Scotia, Canada, which helps to confirm that I have the correct family.

As there are no later Census records available at this time, it is difficult to trace the family any further. The only other records that I have are from the Social Security Death Index :-

It is fascinating to see that, when Sadie was a little girl and a young woman, she was surrounded by parents, grandparents and lots of aunts and uncles. Yet within one generation, the members of the family have moved away from each other and there are very few descendants. There are none named Kelland to carry the Family name forward.
